7:02 PM: The mayor called the meeting to order.

APPROVAL OF THE AGENDA: The agenda was approved as presented.

APPROVAL OF MINUTES: The council minutes from 9/12/2024 were approved as presented.

TREASURER'S REPORT: The Treasurer's Report had an ending balance of \$332,608.59.

It was moved and seconded to approve the Treasurer's Report as presented. Motion Carried. (4/0)

OLD BUSINESS:

- **Burn Site Location:** After Council discussion, it was agreed that this matter will be tabled until all council members are present.
- **Use of Remaining ARPA Money:** The clerk provided the council with a quote from Display Sales for new city Christmas lights and provided a price for new picnic tables at the city park. Discussion followed.

It was moved and seconded for the clerk to obtain a quote from Champlin Tire Recycling for (10) 6' picnic tables and (1) 8' wheelchair accessible picnic table. The Clerk shall purchase the tables first and any remaining money will be used to purchase city Christmas lights. Motion carried (4/0)

- **Agreement for Wells 5&6:** The clerk stated that the information needed was given to the city's attorney Chasen Katz a couple weeks prior for him write the agreements. She spoke with him yesterday and he stated that he would get them to her as soon as possible.

NEW BUSINESS: No New Business.

Mayor's Report: Nothing to report.

Superintendent's Report:

- Adam informed the council that he and the clerk had finished the lead and copper survey, and it has been turned into KDHE.
- The city's oiler needs a new gas tank. After discussion the council told him to purchase a new one.
- One of the pumps at the lift station is leaking and for it to be repaired it would require taking the pump apart. The council discussed the issue and asked Adam to obtain a quote for the installation of the new city pumps.
- The State came for an "inspection." Adam stated they had no concerns.

City Clerk's Report:

- The clerk informed the council that she will begin selling the 2025 dog tags on October 16th.
- A resident was given an Animal Citation for two of their dogs running at large. The Clerk informed Judge Clark and is waiting to hear back from him.
