**TRASH IS PICKED UP ONCE PER WEEK ON MONDAY MORNING. YOU SHOULD HAVE YOUR TRASH CURBSIDE BY 8:00 AM. TRASH WILL ONLY BE PICKED UP IF IT IS CURBSIDE WHEN THE TRASH TRUCK GOES BY.**
